- 1.2. First Party and Second Party Co-operation will facilitate effective utilization of the intellectual Capabilities of the faculty of First Party providing significant

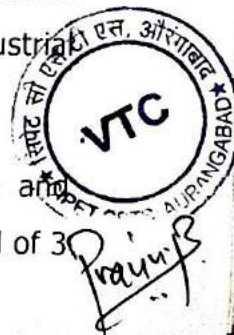



- The Department of Public Administration DCA & VNM will have joint extension and outreach activities in and off campus most probably through study tour.





Terms and Conditions



A MEMORANDUM OF UNDERSTANDING

The MoU would be executed under the following (and not restricted to) the general guidelines:


